### THE RADIO CLUB OF SCOTLAND (CONSTITUTION).

#### 1. NAME

THE CLUB SHALL BE NAMED THE RADIO CLUB OF SCOTLAND.

#### 2. AIMS

- (A) TO HOLD MEETINGS WHERE PERSONS CAN COLLECTIVELY PARTICIPATE IN THE HOBBY OF AMATEUR RADIO.
- (B) TO GIVE TECHNICAL ADVICE TO MEMBERS AND TO ASSIST IN THE SELECTION AND UTILIZATION OF RADIO EQUIPMENT BY ARRANGING DEMONSTRATIONS, TALKS, TECHNICAL FILMS, ETC.
- (c) To encourage the use of the Gaelic Language amongst radio amateurs.

#### 3. MEMBERSHIP

SUBJECT TO COMMITTEE APPROVAL, MEMBERSHIP SHALL BE OPEN TO ANYONE INTERESTED IN AMATEUR RADIO. ALL MEMBERS SHALL BE ENTITLED TO VOTE AT ALL MEETINGS. NO ONE SHALL BE ENTITLED TO THE PRIVILEGES OF MEMBERSHIP UNTIL THE FIRST ANNUAL SUBSCRIPTION SHALL HAVE BEEN PAID.

#### 4. FINANCE

- (A) THE FINANCIAL YEAR SHALL BE FROM 1ST JUNE IN ANY ONE YEAR TO 31ST MAY IN THE FOLLOWING YEAR.
- (B) THE EXPENDITURE OF CLUB FUNDS SHALL BE DETERMINED FOR SUMS NOT EXCEEDING £25 BY THE CLUB COMMITTEE, AND FOR SUMS IN EXCESS OF £25 BY THE MAJORITY DECISION OF THE MEMBERS.

#### 5. SUBSCRIPTIONS

- (A) THE MEMBERSHIP SUBSCRIPTION SHALL BE £1 PER ANNUM.
- (B) SUBSCRIPTIONS SHALL FIRST BE DUE ON ADMITTANCE TO MEMBERSHIP OF THE CLUB, AND THEN ON THE ANNIVERSARY OF THAT DATE IN EACH SUCCEEDING YEAR.
- (c) REMITTANCES FOR SUBSCRIPTIONS SHALL BE MADE TO THE TREASURER WHO HAS THE AUTHORITY TO PROVIDE MEMBERS WITH FINANCIAL ASSISTANCE WHERE NECESSARY.

#### 5. MANAGEMENT

- (A) THE AFFAIRS OF THE CLUB SHALL BE MANAGED BY NINE OFFICIALS DULY ELECTED, WHO SHALL CONSTITUTE THE COMMITTEE OF THE CLUB. THESE SHALL BE: THE CHAIRMAN AND VICE-CHAIRMAN, THE EDITOR AND ASSISTANT EDITOR, THE TREASURER AND ASSISTANT TREASURER, THE SECRETARY AND ASSISTANT SECRETARY, AND THE PUBLICITY/Public Relations Officer.
- (B) THE CLUB OFFICIALS SHALL BE EMPOWERED TO CO-OPT OTHER MEMBERS ON TO THE COMMITTEE DURING THEIR OWN TERM OF OFFICE.
- (C) THE DUTIES OF THE COMMITTEE SHALL BE TO MANAGE THE CLUB IN ACCORDANCE WITH THE AIMS AND OBJECTS AS EXPRESSED IN CLAUSE 2, AND TO INTERPRET ALL MATTERS NOT PROVIDED FOR IN THIS CONSTITUTION.
- (D) NO DECISION MADE BY THE COMMITTEE SHALL OVER-RIDE THE TERMS OF THIS CONSTITUTION, WHICH SHALL ONLY BE ALTERED AT AN A.G.M. OR EXTRAORDINARY GENERAL MEETING ATTENDED BY AT LEAST 60% OF THE MEMBERSHIP AND BY 60% MAJORITY VOTE AT THAT MEETING.

#### 7. ORDINARY MEETINGS

ORDINARY MEETINGS SHALL BE HELD EVERY FRIDAY.

#### 8. ANNUAL GENERAL MEETING

- (A) THE LAST MEETING IN MAY SHALL BE THE A.G.M.
- (B) THE PROCEEDINGS OF THE A.G.M. SHALL ONLY INCLUDE ITEMS IN THE AGENDA, AND ITEMS FOR INCLUSION SHALL BE LODGED WITH THE SECRETARY AT LEAST FOUR WEEKS BEFORE THE DATE OF THE A.G.M.
- (C) AT THE A.G.M. A COMMITTEE SHALL BE ELECTED TO SUCCEED THE RETIRING COMMITTEE. ANY OFFICIAL RETIRING FROM THE PREVIOUS YEAR'S OFFICE MAY BE RE-ELECTED, OR MAY SERVE FOR A FURTHER PERIOD IF THE VACANCY IS NOT FILLED.
- (D) PROPER BOOKS OF ACCOUNTS SHALL BE KEPT BY THE TREASURER DURING THE YEAR, AND A STATEMENT OF ACCOUNTS, DULY AUDITED, SHALL BE MADE AVAILABLE AT THE A.G.M. TO MEMBERS.

#### 9. EXTRAORDINARY GENERAL MEETINGS

MAY BE CALLED AT ANY TIME EITHER BY ORDER OF THE COMMITTEE OR BY REQUISITION FROM AT LEAST FIVE MEMBERS. FOUR WEEKS NOTICE MUST BE GIVEN TO MEMBERS.

#### 10. CLUB LIABILITY

THE CLUB IS NOT RESPONSIBLE FOR ACTIONS TAKEN BY ITS MEMBERS OR DEBTS INCURRED UNLESS AUTHORISED BY THE COMMITTEE IN WRITING.
